## ETHICS AND INTEGRITY COMPLIANCE SCORECARD OF FEDERAL MDAs 2020



### Forward

One of the initiatives introduced by the Independent Corrupt Practices and Other Related Offences Commission in ensuring public organizations adhere to rules and standards is the annual deployment of the Ethics and Compliance Scorecard in Ministries, Departments and Agencies (MDAs).

The Score card is a tool developed to address institutional vulnerabilities which are capable of engendering corrupt practices in public institutions. MDAs are assessed in areas of Management Culture and Structure, Financial Management Systems and Administrative Systems. Outcomes of the deployment form the basis of some of the recommendations from the ICPC to both the government and the MDAs on areas that require intervention and necessary improvement.

In spite of the pandemic and the attendant restrictions, the Commission deployed the Scorecard in 352 MDAs nationwide in 2020. The outcome of the deployment reveals areas of weakness and non- compliance by MDAs that tend to promote corruption vulnerabilities. Such MDAs would be closely monitored by the Commission. Also, while no MDA attained the full compliance score, some MDAs deserve to be commended for their level of compliance to rules and existing structures within their organizations. Notable findings which require government interventions were also discovered during the deployment all of which are contained in the report.

It is disturbing that a number of MDAs declined to respond to the deployed ECS. The Commission views such non-responsive public institutions as apprehensive of the ECS disclosures and are therefore corruption high risk institutions and will be subjected to thorough scrutiny and examination henceforth.

The ICPC will continue to put in efforts to ensure that proper structures are put in place by respective government institutions to promote adherence to ethical standards and government regulations which would aid transparency in government business. MDAs are enjoined to support this initiative by seeing it as an opportunity to improve their systems and take steps to put in place good structures that promote integrity, accountability and service delivery.

### Background

In its 2013 – 2017 Strategic Action plan, the Commission reinforced its drive for probity, strengthening accountability and checking impunity in public systems through prevention. In furtherance of this, the Commission commenced the annual assessment and rating of selected MDAs under the implementation of the ICPC–led Anti-Corruption and Accountability Compliance Initiative.

The Ethics and Compliance Scorecard (ECS) is one of the tools under this initiative that shows the extent to which MDAs have complied with ethical and integrity regulatory standards. The assessments resulting from the application of the scorecard are weighted into specific scores and published for the attention and action of the MDAs and for consideration by the general public.

Ultimately, the goal is to ensure MDAs understand the quality of their statutes and government policies and take into account their level of compliance with ethical and accountability standards for efficiency and service delivery.

#### **Executive Summary**

#### Introduction

The ICPC under its preventive mandate has developed various initiatives targeted at promoting transparency and accountability in public institutions. One of such initiative is the development of the Ethics and Compliance Scorecard. The Commission in collaboration with Justice for All (J4A)/DFID developed and deployed the Ethics and Compliance Score Card (ECS) in 2016 and then in 2019 in partnership with Rule of Law and Anti-Corruption (RoLAC). The Scorecard was again reviewed in 2020 to capture modern trends. The Ethics and Compliance Scorecard which is to be deployed annually evaluates MDAs compliance to ethics, integrity, statutes, policies and regulations based on 3 Key Performance Indicators (KPIs) and sub-indicators.

The Objective of the Scorecard is to create a platform for comparing and analyzing weaknesses that make MDAs susceptible to corruption. In spite of the pandemic and the attendant restrictions, the Commission deployed the Scorecard in 352 MDAs nationwide in 2020. The 2020 deployment was carried out virtually between June and August 2020.

At the conclusion of the deployment, 132 MDAs did not respond to the deployment. The Commission is of the opinion that those institutions are apprehensive of the disclosures that may arise from the ECS and are therefore considered high risk corruption institutions. These MDAs will be subjected to thorough scrutiny and examination henceforth. 220 MDAs responded to the exercise by forwarding their submissions to the Commission. The submissions were comprehensively vetted, analysed and compiled to produce the 2020 ECS deployment report

#### Outcome

The outcome of the analysis revealed that MDAs scored higher under the Financial Management System due to compliance to reforms introduced by the government to ensure that payment transaction systems are automated to aid transparent and accountable systems. The major vulnerabilities are inclined under **Management Culture** & **Structure** and **Administrative systems** which seems to have provided a ground for lack of compliance.

The government's focus is on strengthening Financial Management Systems without looking at the key drivers of the reforms i.e. Management and Administrative Structures is being a major lacuna in entrenching transparent and accountable processes.

Some of the Key Findings from the deployment include:

- i. None of the MDA attained full compliance while **27 MDAs** attained substantial compliance, **77 MDAs** attained partial compliance and **106 non-compliance**.
- ii. 60 MDAs do not have Board/ Governing Councils responsible for policies. This gap creates opportunities for tyranny, abuse and misuse of power and funds by the Management of the affected MDAs.
- iii. All Federal Medical Centres nationwide do not have an Establishment Act thus giving room for the Board and Management of the Hospitals to take arbitrary decisions with no legal backing.
- iv. 88 MDAs violated the provisions of the Public Procurement Act, 2007 in the last 3 years.
- v. 53 MDAs have been on the FIRS tax defaulters list in the last 3 years.

vi. 132 MDAs were non-responsive and classed as **Corruption High Risk MDAs** and will be treated as such.

#### Recommendations

Based on the Findings, the Commission recommends the following amongst others:

- i. Government should take steps to appoint and inaugurate statutory boards for MDAs not having existing boards to speed up policy formulation, implementation and check abuses.
- ii. Enabling law establishing Federal Medical Centres should be enacted to guide policy, operations and efficiency of the Centres.
- iii. Budgetary allocations and releases to poor performing MDAs on the ECS rating should be further scrutinized and where appropriate, held back until identified risks are corrected.
- iv. MDAs that failed to submit their audited accounts to Office of the Auditor General of the Federation and Public Account Committee of the National Assembly as provided by extant regulations should be reprimanded and have their budgetary releases withheld.

#### Conclusion

The Commission on its part would continue to deploy annually the Scorecard to ensure that MDAs put in place proper structures that would promote adherence to ethical standards and government regulations in their operations and service delivery.

## ETHICS AND COMPLIANCE SCORECARD 2020

## **1. INTRODUCTION**

Prevention is central to the functions of the Independent Corrupt Practices and Other Related Offences Commission (ICPC) as provided for in Section 6 (b-d) of the Corrupt Practices and Other Related Offences Act, 2000. In pursuance of this, the Commission in collaboration with Justice for All (J4A)/DFID developed the Ethics and Compliance Score Card (ECS) in 2015. The Ethics and Compliance Scorecard evaluates MDAs compliance to ethics, integrity, statutes, policies and regulations based on three Key Performance Indicators (KPIs):

Management Culture and Structure (MCS)

- ➢ Financial Management Systems (FMS)
- Administrative Systems (AS)

The Commission conducted the pilot deployment of the scorecard in 20 MDAs in 2016. The second deployment was undertaken in 280 MDAs across the 36 States of the Federation in 2019. The 2020 deployment was carried out between June and August 2020. The ECS is a monitoring and evaluation tool domiciled in Corruption Monitoring and Evaluation Department (CMED).

### 2. OBJECTIVES

ECS deployment is particularly to track ethical, integrity and compliance deficiencies in the MDAs and proffer remedial actions to both management of the MDAs and the government as appropriate. For Ministries, Departments and Agencies' effectiveness and responsiveness, the Key Performance Indicators (KPIs) in the scorecard as configured are to identify some ethics and integrity standards that MDAs must comply with in the areas of Management, Performance, Service and Professional Conduct.

Therefore, the Commission's assessment of MDAs on ethics and integrity compliance issues is to achieve the following:

- a) As a comparative assessment tool for the MDAs, it creates a platform for comparing and analyzing weaknesses that make MDAs susceptible to corruption
- b) Monitor and evaluate MDAs based on Key Performance Indicators (KPI) and determine their level of compliance with institutional Ethics and Integrity requirements
- c) Enable MDAs have and evaluate feedbacks on performance and utilize the documents for future improvement
- d) Serves as a self-assessment tool that provides MDAs the opportunity to internally drive the fight against corruption
- e) Presents the ICPC with a tracking diagnostic tool to monitor system risks and vulnerabilities and direct management and leadership to take appropriate steps to check them.

## 3. METHODOLOGY

Due to the Covid 19 pandemic and the restrictions imposed, the deployment in 2020 was conducted virtually. This development prevented the Commission's teams from physically visiting selected MDAs across the country.

352 MDAs were selected considering the various sectors, their contributions to the economy, importance of agencies in ensuring government drive for efficient service delivery and the commission's mandate to ensuring transparency and accountability in public institutions.

MDAs were informed via a letter to download the tools from the Commission's website through a link provided in the letters, complete the tools, upload their evidential documents and submit within the timeline stipulated. The ECS has a provision requiring Chief Executive Officers to ensure the instruments were completed correctly and truthfully by their MDAs. Contact persons and their phone numbers were also required to be submitted by the MDAs for ease of deployment and clarification of issues and questions.

#### 4. LIMITATIONS

- i. Effect of the COVID-19 pandemic including irregular working hours and movement restrictions of appropriate personnel made it challenging for some MDAs to respond to the ECS.
- ii. Virtual deployment being implemented for the first time, created certain challenges: MDAs complained of lack of access to internet; lack of appropriate staff to act; difficulty in uploading large documents and materials supposedly forwarded on-line were not clear.
- iii. Many MDAs declined to forward contact persons to relate between the Commission and their respective MDAs for ease of deployment.
- iv. Certain tertiary institutions claimed they were on strike and would not respond to official correspondence during the industrial action.

## 5. ANALYSIS

220 MDAs forwarded their submissions within the set time frame. Responses from the organizations were comprehensively vetted, analysed and compiled to produce the 2020 ECS deployment report.







The above pictorial analysis shows that Management Culture and Structure key indicator allotted **30%** has a total average score of **10.9%**. Further expansion to sub-indicators of Organisational Culture and Structure (**10%**), Board Governance (**10%**) and Executive Management **10%** revealed scores of **4.2%**, **3.2%** and **3.5%** respectively. These are below the average of **5%**. The outcomes are indicated in red colour with arrows and dot above.


The second key indicator i.e. Financial Management Systems allotted **40%** obtained a percentage score of **21.5%** which is within the average mark. Further expansion to sub-indicators under the Financial Management Systems (Finance and Account **10%**, Audit **10%**, and Procurement **20%**) revealed that these indicator scores are within average in the order of **6.4%**, **5.0%** and **10%** respectively as indicated in green colour.

The third key indicator, the Administrative Systems allotted **30%** also has an average score of **12.6%** which is less than the average mark of **15%**. Further analyses of the scores on the sub-indicators (Policies, Procedures and Records **5%**; Ethics and Compliance Education **5%**; Anti-Corruption and Transparency Unit **10%**; Complaints and Whistle Blowing Mechanisms **5%**; and Discipline, Sanctions and Rewards Regime **5%**) show percentage scores of **2.7%**, **1.3%**, **3.8%**, **1.4%** and **1.9%** respectively which are all below the average score except for policies, procedures and records with **2.7%** which is a little above expected half mark of **2.5%**.

It can be inferred that the scores obtained under the Financial Management Systems is largely due to reform efforts undertaken by government to ensure that payment transaction systems are automated e.g. GIFMIS, TSA, IPPIS, REMITA and other e-platforms that aid transparent and accountable systems which ultimately reduce corruption vulnerabilities within the organisations in doing government businesses.

Secondly, from the outcomes, it can also be deduced that the major vulnerabilities lie under **Management Culture** & **Structure** and **Administrative systems** which seem to have provided a ground for lack of compliance. The government's focus on strengthening Financial Management Systems without looking at the key drivers of the reforms i.e. Management and Administrative Structures is a major lacuna in entrenching transparent and accountable processes.

Government through the relevant agencies should enhance its reform processes to cover policies, procedures and records keeping. This can be achieved through new and innovative rules and regulations and the institutionalisation of these principles through the Anti-Corruption and Transparency Units (ACTUs) in the respective MDAs. Each MDA should also be advised/ directed to strengthen its complaints and whistle blowing mechanism; ensure the enforcement of discipline and sanctions and encourage reward for role models through a reward regime that is transparent.



#### **6. FINDINGS**

- i. None of the MDAs attained full compliance while 27 MDAs attained substantial compliance, 77 MDAs attained partial compliance and 106 non-compliance.
- ii. Scores obtained by MDAs are below average of the allotted attainable score due to absence of required components of the compliance standard and some MDAs did not submit relevant supporting evidence, indicating poor record keeping.
- iii. 151 out of 210 MDAs do not have a system for staff to sign off as having read and understood its core values, mission, and vision, a key direction in MDAs' achievements of their goals.

- iv. 143 MDAs do not have defined and domesticated policies regarding acceptance of gifts, donations and hospitality which is a prime vulnerability point for corruption.
- v. 60 MDAs do not have Board/ Governing Councils responsible for policies. This gap creates opportunities for tyranny, abuse and misuse of power and funds by the Management of the affected MDAs.
- vi. All Federal medical centres nationwide do not have an Establishment Act thus giving room for the Board and Management of the Hospitals to take arbitrary decisions with no legal backing.
- vii. 96 MDAs do not have Strategic Action Plan, and where they exist, they do not support ethics and compliance education activities, and monitoring and evaluation component.
- viii. 107 MDAs did not comply with government directive to create an Asset Verification Unit.
- ix. 59 MDAs breached Financial Regulation on channel of reporting of Internal Auditors requiring direct reporting to Chief Executive Officers. Internal Audit reports of some MDAs go through the Director Special Duties to the Director General.
- x. 119 MDAs did not submit their audited accounts to the Office of the Auditor General of the Federation and Public Accounts Committee for 2019 as required.
- xi. 101 MDAs did not submit their audited account to the Office of the Auditor General of the Federation and Public Accounts Committee for the last three years.
- xii. 101 MDAs do not have records of conducting Needs Assessment as required by the Public Procurement Act, 2007 and this suggests over bloating of budget as well as purchase of obsolete/ needless items.
- xiii. 96 MDAs do not have fully computerized systems, thus encouraging huge paper trail and falsification of records.
- xiv. 92 MDAs do not have functional ACTU; this suggests lack of Management support/commitment to government Anti- Corruption initiatives.
- xv. 124 MDAs lack ethics and compliance education activities.
- xvi. 141 MDAs do not have whistle blowing policies and mechanisms to encourage information sharing on corruption activities.

- xvii. 179 managements of MDAs do not support the conduct of Systems Studies and Review (SSR) or Corruption Risk Assessments (CRAs) and therefore do not explore or direct results of System Studies/ Corruption Risk Assessments to mitigate institutional weaknesses and vulnerabilities.
- xviii. All federal universities and some institutions are not in compliance with Public Procurement Act, 2007.

#### 7. RECOMMENDATIONS

- i. Government should appoint and inaugurate statutory boards for MDAs not having existing boards to speed up policy formulation, implementation and check abuses.
- ii. Budgetary allocations and releases to poor performing MDAs on the ECS rating should be further scrutinized and where appropriate, held back until identified risks are corrected
- iii. Periodic training on system review, risk assessment, needs assessment etc should be conducted for Heads of MDAs and management of agencies by the Commission.
- iv. Enabling law establishing Federal Medical Centres should be enacted to guide policy, operations and efficiency of the Centres.
- v. To sustain the focus and direction of MDAs, they should be directed to put in place a system for staff to sign off as having read and understood core values, mission and vision of the agencies through a commitment document.
- vi. MDAs should be directed to institute policies on acceptance of gift, donation, hospitality, etc to curtail vulnerability to corruption.
- vii. MDAs should be impressed upon to formulate strategic action plan with components on ethics and compliance activities and monitoring and evaluation.
- viii. Management of MDAs should inculcate ethics and compliance education in its training programmes to ensure integrity, transparency and accountability of the systems.
- ix. All MDAs should create asset verification units in compliance with extant guidelines.

- x. MDAs not in compliance with the financial regulations on channel of reporting of internal auditors to the Chief Executive Officers of the MDAs, should be directed to do so forthwith.
- xi. MDAs that failed to submit their audited accounts to Office of the Auditor General of the Federation and Public Account Committee of the National Assembly as provided by extant regulations should be reprimanded and have their budgetary releases withheld.
- xii. MDAs should be mandated to comply fully with the provision of the Public Procurement Act, 2007 and the Bureau for Public Procurement (BPP) should be directed to ensure strict compliance by agencies and where necessary sanction erring agencies in accordance with provision of the Act.
- xiii. Government should ensure full implementation of e-governance policy in all aspects of operations in the MDAs through full computerisation of its system as it minimises person-to-person contact and eliminates paper trail that can be easily falsified.
- xiv. The Office of the Secretary to the Government of the Federation (OSGF) and the Office of the Head of Service of the Federation should ensure that Chief Executive Officers of MDAs comply strictly with the extant circulars on establishment and operations of ACTUs in the MDAs and the ICPC should heighten effective monitoring and compliance.
- xv. The Commission should mandate MDAs to have whistleblowing policy in place and periodically train them for openness, transparency accountability, integrity and better service delivery.
- xvi. The Commission should ensure training for MDAs on the Ethics and Compliance Scorecard so as to lessen challenges of understanding the tools, putting up required ethical and other structures and compliance.
- xvii. The Commission should consider conducting sectoral deployments in future exercises for ease of deployment, cost effectiveness and sector specific interventions.
- xviii. Agencies that did not respond to the Commission's directives on the deployment should be thoroughly investigated particularly on their recurrent, personnel and capital funds expenditure. MDAs who refused to submit supporting documents claiming security reasons should also be investigated.

- xix. Since virtual engagements are becoming routine and considering 2020 deployment of the ECS which received an average response from the MDAs, the Commission is advised to have a dual deployment approach physical and virtual.
- xx. MDAs with substantial compliance should be commended and encouraged by the Commission to continue their institutional and ethical compliance programmes.

#### 8. CONCLUSION

The new normal of the COVID 19 pandemic compelled virtual operation and engagement in the recent deployment of ECS. However, essence of physical enquiry for details and assessment in the deployment of ECS should not be lost in subsequent exercise or programmes. While virtual deployment is vital as compelled by present emergencies and exigencies, it is also important that the deployment of these tools should not be perceived as mere annual ceremonial routine to meet or satisfy certain records or statistics. The diagnostics should be pressed to ensure the vulnerabilities and risks are mitigated for the well-being and growth of the MDAs and check the growing misconception that being a preventive tool, it could be dispensed with and not accorded the same attention given its enforcement counterpart.

Considering the vulnerabilities identified by the ECS in MDAs and the suggestions made to mitigate them, the Commission believes the public service will be better sanitized for productivity and service delivery in all ramifications.
