- 5. Members of the legal profession particularly members of NBA-SPIDEL are very disturbed by the content of this video.
- 6. Chidi Odinkalu, a senior lawyer posted the video on X formerly known as Twitter and called out the respondent for snatching ballot boxes accompanied by thugs during the election.
- 7. That till date, the respondent did not refute, deny, or challenge the allegations on the social media or the specific allegations of Chidi Odinkalu.
- 8. Pursuant to her mandate and mission, NBA-SPIDEL resolved to refer this matter to the Legal Practitioners' Disciplinary Committee for necessary action hence this petition. Accompanied herewith are copies of the petition, copies of my statement on oath in support of the petition and annexed exhibits.
