### **OBJECTION TO THE APPOINTMENT OF MR. YAKUBU CHONOKO MAIKYAU, SAN, PRESIDENT OF THE NIGERIAN BAR ASSOCIATION (NBA) AS A MEMBER OF THE PERMANENT COURT OF ARBITRATION (PCA)**

The Nigerian Bar Association Section on Public Interest and Development Law (NBA-SPIDEL) is one of the three sections of the Nigerian Bar Association (NBA). The mandate of NBA-SPIDEL is to promote the rule of law, defend the rights of the people, and intervene in matters of public interest that affect the Nigerian people.

The NBA-SPIDEL is mandated to ensure that the actions of government and its agencies conform with the rule of law. The NBA-SPIDEL aims to promote development, advance human rights, and safeguard the public interest.

On its part, the NBA is the leading civil society organization in Nigeria. The motto of the NBA is "promoting the rule of law." The NBA relies on NBA-SPIDEL to discharge its public interest mandate in particular.

Mr. Yakubu Chonoko Maikyau, the subject of this petition, is a legal practitioner, a Senior Advocate of Nigeria, and the current President of the Nigerian Bar Association (NBA). It is the reasonable expectation of NBA members, the NBA-SPIDEL and Nigerians that Mr. Yakubu Chonoko Maikyau, SAN should be guided by respect for the rule of law and particularly by the objectives of the Nigerian Bar Association in the discharge of his duties. Mr. Yakubu Chonoko Maikyau, SAN is expected to exhibit and maintain a very high standard of conduct, professionalism, and respect for the integrity of Nigeria's courts and the judicial process.

Accordingly, Mr. Yakubu Chonoko Maikyau, SAN lacks the capacity (as a member of the Permanent Court of Arbitration) to dispense justice in line with the rule of law.

The conduct of Mr. Maikyau so far as outlined above clearly demonstrates that he lacks such highest moral reputation expected of a person to represent Nigeria as member of the Permanent Court of Arbitration as required by the relevant charter of the Court.

**C. OUR HUMBLE DEMANDS**



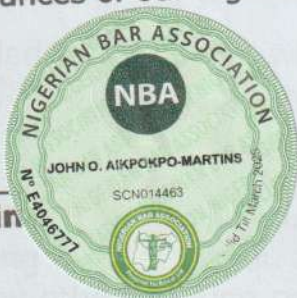
We believe that Your Excellency was not aware of the foregoing facts prior to the unfortunate nomination, hence this objection is addressed to you in the first instance.

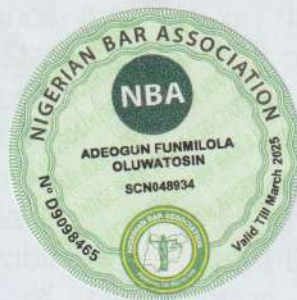
