

STATEMENT BY THE BOARD OF TRUSTEES, UNIVERSITY OF MAIDUGURI ALUMNI ASSOCIATION

To all esteemed members of the University of Maiduguri Alumni Association,

The Board of Trustees of the University of Maiduguri Alumni Association (BOT) hereby wishes to inform all members of the Association that a meeting was held on Tuesday, 25th February, 2025 with the Dr. Mohammed Bulama-led National Caretaker Committee, the Vice-Chancellor of the University of Maiduguri, Prof. Mohammed Laminu Mele and some critical stakeholders on update of the National Caretaker Committee's activities since its inauguration.

The meeting culminated in the adoption of the following resolutions, amongst others:

1. The Prof. Maxwell Gidado, SAN-led Constitution Amendment Committee shall review and propose amendments to the extant Constitution.

5. The BOT and National Caretaker Committee will collaborate with University Authorities to ensure a memorable 50th Anniversary celebration scheduled for **Monday, 10th November, 2025**.

As the National Caretaker Committee enters the final phase of its mandate, culminating in a seamless handover to elected executives, we urge all members of the Association to intensify their support and cooperation. Let us collectively rally behind the Committee, promoting a spirit of unity, cooperation, and shared purpose.
