

The Estate of Late Mrs Esther Ibeto V. Ms Uche Ibeto

Case Summary

Case filed in the High Court of Justice, Lagos State, Nigeria, in the Ikeja Judicial Division.

The case involves Mrs. Laura Chinyelu Okoh (the Administrator of the Estate of their late mother, Mrs. Esther Ibeto) (the Claimant) who is suing her sister, Ms. Uche Ibeto (Defendant),.

The Claimant alleges that the Defendant unlawfully took possession of cash, valuables, property title documents, and rental income belonging to the Estate after their mother's death. The Defendant is also accused of interfering with the lawful administration of the estate and using unscrupulous members of the police to harass and intimidate the Claimant; publishing defamatory statements about the Claimant, falsely claiming ownership of the Estate's property, and causing harm to the Estate's reputation. The Claimant further alleges that the Defendant financially exploited their mother during her terminal illness, physically abused her and stole money and valuable items belonging to their mother.

The Claimant seeks several legal remedies, including:

1. Declarations that the Defendant's actions were unlawful, illegal, and defamatory.
2. Orders for the Defendant to return all assets, provide a full account of the Estate's finances, and publish a retraction and apology for the defamatory statements.
3. Monetary compensation of N10,000,000 for defamation and N10,000,000 for the cost of the legal action.
4. An order for the Defendant to account for £10,000 (Ten thousand Pounds) allegedly withdrawn from the deceased's Barclays Bank account.
5. Perpetual injunctions restraining the Defendant from interfering with the Estate or publishing further defamatory statements.
6. Interest on monetary claims and damages.

The document includes witness statements, a list of witnesses, and a list of documents that the Claimant intends to rely on during the trial. Witnesses include several family members, a professional carer for the deceased, and representatives from Barclays Bank UK. The Claimant has attached evidence such as letters of administration, demand letters, press publications, bank records, and property documents to support her claims.

WHEREOF the Claimant claims against the Defendant as follows:

1. **A DECLARATION** that the Defendant sponsored publications representations purporting that the Defendant is the owner of the Estate properties of the Late Mrs. Esther Ibeto are false, malicious and defamatory.
2. **A DECLARATION** that the Defendant acts of unlawful withdrawal, conversion and appropriation of monies, valuables and title documents belonging to the Estate of the Late Mrs. Esther Ibeto are wrongful, illegal and constitute a breach of trust.
3. **AN ORDER** of this Honourable Court directing the Defendant to Publish a well worded retraction and apology to be published in a similar manner in an edition of The Premier newspaper and Sahara Reporter that has a wide publication in Nigeria as may be determined by the Court and within such time after the judgment as the Honourable Court may direct.
4. **AN ORDER** of this Honourable Court directing the Defendant to render a full and verifiable account of all monies, rental income, and assets of the Estate of the Late Mrs. Esther Ibeto in her custody.
5. **AN ORDER** of this Honourable Court directing the Defendant to return forthwith all monies, title documents, valuables and Estate assets unlawfully taken from the Estate.
6. **AN ORDER** of this Honourable Court awarding the sum of **₦10,000,000 (Ten Million Naira)** as general damages for defamation against the estate of Late Mrs. Esther Ibeto.
7. **AN ORDER** of this Honourable Court directing the Defendant to render an account of the sum of **£10,000 (Ten Thousand Pounds Sterling)** being monies unlawfully withdrawn from Late Mrs. Esther Ibeto's Barclays Bank account.
8. **AN ORDER OF PERPETUAL INJUNCTION** restraining the Defendant, her servants, privies or agents from further interfering with the Estate of Late Mrs. Esther Ibeto or parading herself as owners thereof.
9. **AN ORDER OF PERPETUAL INJUNCTION** restraining the Defendant from any further publication of defamatory statements concerning the Claimant or the Estate.
10. **AN ORDER** directing the Defendant to pay Interest on all monetary claims at the rate of 21% per annum from 2013 until judgment, and 10% thereafter until final liquidation.
11. Cost of action in the sum of **₦10,000,000 (Ten Million) Naira** only

STATEMENT OF CLAIM

1. The Claimant is the first daughter of the late Mrs. Esther Ibeto (**deceased**) and the duly appointed Administrator of her Estate, pursuant to Letters of Administration issued by the Lagos state probate Registry, Ikeja division.
2. The claimant files this action in a representative capacity on behalf of the estate of Mrs. Esther Ibeto in her capacity as an Administrator of the Estate.
3. The Claimant and the Defendant are siblings of the same parents.
4. After the demise of the Claimant's Mother in 2013; who died intestate, the Claimant and her second sibling applied for a letter of Administration at the Ikeja probate Registry of the Lagos High Court.
5. On 24th day of October 2014, the Lagos State Probate Registry, Ikeja division granted a letter of Administration of the Estate of late Mrs. Esther Ibeto (**Deceased**) to Mrs. Laura Chinyelu Okoh (the Claimant) and Mrs. Ifeoma Stella Ilodibe as the Administrators of the Estate. **The Claimant shall rely on the Letters of Administration at the trial of this suit.**
6. The Defendant, Ms. Uche Ibeto is the third daughter of the Three surviving Children.
7. Mrs. Ifeoma Ilodibe, the second Administrator authorised the Claimant sometime in April 2025 by her handwritten letter authorised the Claimant to deal with the Estate of **Mrs. Esther Ibeto** as she so desire. **The Claimant shall rely on the handwritten note at the trial of this suit.**
8. The Claimant avers that immediately after the demise of the deceased in 2013, the Defendant unlawfully broke into the deceased's bedroom, forcibly removed and converted to her personal use:
 - i. Cash exceeding ₦35,000,000 (Thirty-Five Million Naira);
 - ii. Jewellery, clothing, and valuables worth over ₦250,000,000 (Two

Hundred and Fifty Million Naira);

iii. Original title documents of landed properties belonging to the deceased.

9. The Claimant avers that during the deceased's terminal illness in the United Kingdom; the Defendant unlawfully accessed the deceased's Barclays Bank account and withdrew the sum of **£10,000 (Ten Thousand Pounds Sterling)** without consent or lawful authority.
10. The Claimant further avers that the Defendant, without lawful authority from the administrators of the estate has rented out various portions of the deceased's property, including the boys' quarters, garages, and flats, and has converted rental income more than ~~₦~~25,000,000 (Twenty-Five Million Naira) to her personal use. **The Claimant shall rely on the rental receipts and tenancy agreement issued by the Defendant at the trial of this suit**
11. The Claimant avers that, despite repeated requests and demands, the Defendant has persistently refused, neglected, and failed to provide an account for or return the monies, valuables, and documents that were unlawfully removed from the deceased and the Estate. These assets, which are rightfully part of the Estate of the late Mrs. Esther Ibeto, remain in the Defendant's possession without lawful justification or explanation. In support of these claims, the Claimant will rely, at the trial of this suit, on a formal letter dated 20th August 2025, which was issued to the Defendant, demanding the immediate return of the Estate assets still held by her.
12. The Claimant further states that, following the Defendant's persistent refusal and neglect to account for the estate assets in her possession, as well as her ongoing dissipation of the remaining assets, it became necessary to take decisive action in the best interest of the estate. Considering these circumstances, and to protect and preserve the interests of all beneficiaries, the Claimant made the decision to sell the one-storey building situated at No. 36 Ibezim Obiajulu Street, Surulere, Lagos with the intention to share the proceeds realised among the beneficiaries of the estate, ensuring that each party received their rightful entitlement in accordance with the duties.
13. Rather than providing a proper account of the estate properties in her custody, the Defendant responded by threatening to harass and embarrass the Claimant. The Defendant subsequently acted upon these threats by colluding with certain unscrupulous police officers to intimidate and arrest staff and employees of the Estate. In support of these averments, the Claimant will rely on a petition, dated 15/09/2025, addressed to the Assistant Inspector General of Police, Zone 2, regarding the unlawful interference by these police officers, which will be presented at the trial of this suit.
14. The Claimant avers that on or about 2025, the Defendant caused and/or sponsored the publication of malicious, false and defamatory statements

in the press, wherein she falsely represented Ms Uche Ibeto as the owner of Estate property, maliciously disparaged the Claimant in her capacity as Administrator, and misled the public as to the true ownership of the Estate's assets.

15. The said defamatory publications have lowered the Claimant in the estimation of right-thinking members of society, brought the administration of the Estate into disrepute, and injured the Estate's reputation.

16. The Claimant avers that the specific statements in question include where the Defendant sponsored a publication on Sahara Reporters on 9th of September 2025, wherein she falsely alleged as follows:

- a. "My elder Sister in connivance with a judicial officer and Cecil Ezem Osakwe forcedly evicted me from my home"
- b. "Mrs. Laura Okoh working with a judicial officer, conspired to Eject me from the house where she had lived for more than 50 years with their mother until she died in 2013"

17. The Claimant avers that by the said publication, the Defendant meant or were capable of being understood to mean and were indeed understood by ordinary members of the public to mean that the Claimant is a fraud.

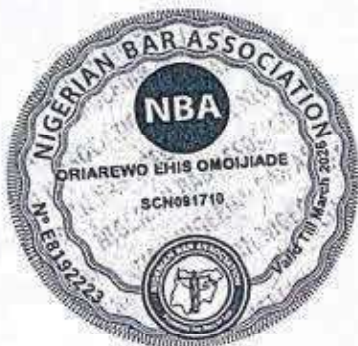
18. The Claimant has suffered grave loss, damages, and embarrassment because of the Defendant's wrongful publications.

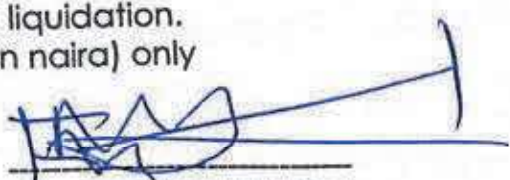
WHEREOF the Claimant claims against the Defendant as follows:

1. **A DECLARATION** that the Defendant acts of unlawful withdrawal, conversion and appropriation of monies, valuables and title documents belonging to the Estate of the Late Mrs. Esther Ibeto are wrongful, illegal and constitute a breach of trust.
2. **A DECLARATION** that the Defendant's publications and representations purporting that the Defendant is the owner of the Estate property are false, malicious and defamatory.
3. **AN ORDER** of this Honourable Court directing the Defendant to render a full and verifiable account of all monies, rental income, and assets of the Estate of the Late Mrs. Esther Ibeto in their custody.
4. **AN ORDER** directing the Defendant to return forthwith all monies, title documents, valuables and Estate assets unlawfully taken from the Estate.
5. **AN ORDER** of this Honourable Court awarding the sum of **₦10,000,000 (Ten Million Naira)** as general damages for defamation against the estate of Late Mrs. Esther Ibeto.
6. **AN ORDER** of this honourable Court directing the Defendant to render an account of the sum of **£10,000 (Ten Thousand Pounds Sterling)** being monies unlawfully withdrawn from the deceased's Barclays Bank account.

7. **AN ORDER OF PERPETUAL INJUNCTION** restraining the Defendant, her servants, privies or agents from further interfering with the Estate of the Late Mrs. Esther Ibeto, parading themselves as owners thereof.
8. **AN ORDER OF PERPETUAL INJUNCTION** restraining the Defendant from publishing defamatory statements concerning the Claimant or the Estate.
9. Interest on all monetary claims at the rate of 21% per annum from 2013 until judgment, and 10% thereafter until final liquidation.
10. The cost of this action in sum (Five million naira) only

WITNESS STATEMENT ON OATH

I, **MRS. LAURA CHINYELU OKOH**, female, Christian, Nigerian citizen, teacher, of 26 Babatunde Ladega Street, Omole Phase 1, Ikeja, Lagos State, do hereby make oath and state as follows:

1. That I am the Claimant in this suit and the duly appointed **Administrator of the Estate of the Late Mrs. Esther Ibeto** (the "Estate"), by virtue of Letters of Administration issued on 24th of October 2014.
2. That I am conversant with the facts of this case, and by virtue of my position as Administrator, I am competent to depose to this statement.
3. That on 24th day of October 2014, the Lagos State Probate Registry, Ikeja division granted a letter of Administration of the Estate of late Mrs. Esther Ibeto (Deceased) to me and my younger Sister Mrs. Ifeoma Ilodibe as the Administrators of the Estate. **The letter of Administration is hereby attached and marked as "EXHIBIT W1"**
4. That the Defendant, Ms. Uche Ibeto is the third daughter of the Three surviving Children of late **Mrs. Esther Ibeto** and a sister to the Claimant.
5. That Mrs. Ifeoma Ilodibe, the second Administrator sometime in April 2025 by her handwritten letter authorised me to handle and deal with the affairs of the Estate of our late mother, **Mrs. Esther Ibeto** as she so desire. **The handwritten letter dated 22nd day of April 2025 is hereby attached and marked as "EXHIBIT W2"**
6. That during the lifetime of our late mother, and particularly while she was terminally ill in the United Kingdom in 2013, the Defendant without authority

accessed her Barclays Bank account and withdrew the sum of **£10,000 (Ten Thousand Pounds Sterling)**.

7. That immediately following the demise of our late mother, the Defendant unlawfully broke into her bedroom and carted away valuables and assets belonging to the deceased, including:
 - a. Cash exceeding **₦35,000,000 (Thirty-Five Million Naira)**;
 - b. Jewellery, clothing and valuables worth over **₦250,000,000 (Two Hundred and Fifty Million Naira)**; and
 - c. Original title documents to the deceased's landed properties.
8. That despite repeated demands, the Defendant has failed, refused and neglected to return the said monies, valuables and documents, nor has she rendered any account to the Estate. **A demand letter dated 20th of August, 2025 addressed to the Defendant is hereby attached and marked as "EXHIBIT W3"**
9. That the Defendant has also, without authority, rented out various portions of the deceased's property, including garages, boys' quarters and flats, and has unlawfully converted rental income in excess of **₦25,000,000 (Twenty-Five Million Naira)** to her personal use. **Rental receipts and tenancy agreement issued by the Defendant is hereby attached and marked as "EXHIBIT W"**.
10. That when the Defendant refused, neglected to account for the assets of the estate in her possession and will not stop dissipating the remaining assets of the estate, I decided it was in the best interest of the estate to sell the one-story building at No 36 Ibezim Obiajulu Street, Surulere and shared the proceed among the beneficiary of the estate.
11. That I acted in the best interest of the estate of Late Mrs. Esther Ibeto when I exercised my discretion as an administrator of the estate in order to protect the interest of other beneficiaries of the estate.
12. That instead of accounting for the rental income of the property, the Defendant has threatened to deal with and embarrass me.
13. That on or about 2025, the Defendant caused the publication of malicious and defamatory statements in the press, falsely representing Uche Ibeto as owner of Estate property, disparaging my person and undermining the lawful administration of the Estate.
14. That the said publications are false, malicious, mischievous and intended to mislead the public, injure the reputation of the Estate, and frustrate my work as Administrator.
15. That the specific statements in question include where the Defendant sponsored a publication on Sahara Reporters on 9th of September 2025, wherein she falsely alleged as follows:

- a. "My elder Sister in connivance with a judicial officer and Cecil Ezem Osakwe forcedly evicted me from my home"
- b. "Mrs. Laura Okoh with a judicial officer, conspired to Eject me from the house where she had lived for more than 50 years with our mother until she died in 2013"

16. That because of the Defendant's publications, the Estate has suffered grave loss and embarrassment, and the confidence of right-thinking members of the public in the administration of the Estate has been undermined.

17. That unless restrained by this Honourable Court, the Defendant will continue with her unlawful acts to the further detriment of the Estate.

18. That I depose to this Affidavit in good faith believing same to be correct and in accordance with Oath Law of Lagos State.

WITNESS STATEMENT ON OATH

I, **MRS. WILMA WILLIE**, female, Christian, Nigerian citizen, Pastor and radiographer, of 11 Lawrence Court, Seacroft Gardens, Watford, United Kingdom, do hereby make oath and state as follows:

1. That I was a professional carer in London for the late **Mrs. Esther Ibeto**, fondly called "Mama", from February 2010 to July 2013.
2. That by virtue of my close and consistent care for Mama over several years, I am fully conversant with the facts of this matter and therefore competent to depose to this affidavit.
3. That while in London, Mama resided primarily at the home of her second daughter, **Mrs. Ifeoma Ilodibe**, at 22 De Montfort Road, Streatham Hill, London.
4. That I visited Mama several times weekly to assist with her personal care, meals, medical appointments, and errands.
5. That I personally observed that Mama was not adequately cared for by her daughters, particularly **Mrs. Ifeoma Ilodibe** and **Ms. Uche Ibeto**.
6. That Mama frequently complained of hunger and neglect, stating that she was often left unfed when I was not present.
7. That when I confronted Ifeoma and Uche regarding their mother's welfare, Ifeoma casually stated that she "told the maid to feed her," while Uche shockingly referred to her own mother as an "old witch" and declared she would never care for her.

8. That I was deeply disturbed by the cold and heartless attitudes displayed by both daughters towards their elderly, ailing mother.
9. That due to their neglect, I increased my visits to four times weekly to ensure Mama was bathed, cleaned, and fed.
10. That Mama's physical and emotional wellbeing improved only during my care visits, which further confirmed the pattern of neglect by her daughters.
11. That in 2012, while in Nigeria, Mama called me in tears stating that **Uche Ibeto** had forcibly taken her house keys and locked her out of her own property at 36 Ibezim Obiajulu Street, Surulere, Lagos.
12. That I personally travelled to Nigeria to mediate, but Uche was openly defiant and swore that no one would remove her from Mama's property, and This pattern of **domineering behaviour and entitlement** was consistent with how both daughters treated their mother. As a burden and as a source of financial gain.
13. That in December 2012, I received a distress call from **Mr. Ifeanyi Okoh**, Mama's grandson, reporting that Mama had called him crying because **Ifeoma** had ordered her to vacate the house or be locked out.
14. That when I called Ifeoma, she told me, *"Wilma, come and take your grandmother out of my house. I am travelling to Nigeria for Christmas and will not leave my home open to anyone."*
15. That despite being reminded that Mama was gravely ill with cancer, Ifeoma refused to show any compassion.
16. That I immediately went to Streatham Hill, collected Mama, and took her to my home in Watford, where she stayed for several months until her return to Nigeria in 2013.
17. That during this entire period, neither Ifeoma nor Uche called to enquire about their mother's wellbeing.
18. As Mama's condition worsened, I assisted her in accessing her government benefits and opened a **Barclays Bank account** in her name for her personal use.
19. When Mama was later hospitalised at St. George's Hospital, she confided in me that her daughters **Ifeoma and Uche had pressured and intimidated her** into withdrawing **£10,000** from her account.
20. Mama said she was **terrified** and that they took her in her wheelchair to the bank, where they **coerced her** into handing over the money in cash.
21. That Given her frailty and inability to walk, it was clear she could not have managed such a withdrawal on her own.
22. That their actions amounted to **financial abuse of a vulnerable, terminally ill woman**.
23. That given Mama's frail and bedridden condition, she could not have executed this withdrawal unaided.
24. That I verily believe she was coerced and financially exploited by her daughters.

19. Uche had **physically assaulted** Mama, including pushing her down the stairs at her Surulere home.
20. Uche routinely **insulted** her mother and withheld rent collected from tenants in Mama's house.
21. Ifeoma, on her part, frequently **demanding money** from Mama and displayed **emotional cruelty** and disrespect.
22. Mama often described her experiences as "*deeply painful*", saying she felt "**severely abused and maltreated**" by both Ifeoma and Uche.
23. That Mama told me she kept her property documents securely under her bed and never gave them to anyone, especially not to **Uche**.
24. That she expressed deep fear that Uche might unlawfully seize her property and, in her anguish, placed a curse on her should she ever do so.
25. That I pleaded with Mama to revoke the curse, but she refused, saying Uche's wickedness had destroyed her peace.
26. That after Mama's passing, I became aware that **Uche broke into Mama's bedroom** and took valuables and documents.
27. That false media claims later appeared suggesting Mama gave Uche the property documents; I state emphatically that this is untrue.
28. That in all my years of caring for Mama, I witnessed a gentle, kind, and deeply spiritual woman who was subjected to **unimaginable cruelty** by her own children
29. That no mother deserves such cruelty, neglect, and exploitation, particularly during terminal illness.
30. That I depose to this Affidavit in good faith believing same to be correct and in accordance with Oath Law of Lagos State.
