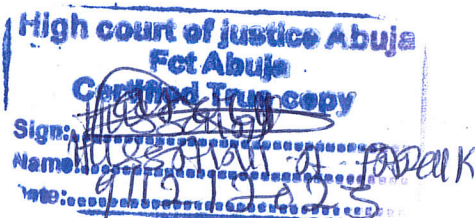
COURT ORDER

Motion Ex-parte with Motion No. M/16245/2025 is granted as prayed.


ITS HEREBY ORDERED AS FOLLOWS:-
