

**REPORT OF THE NBA SPIDEL'S 2025 ELECTORAL SUB-COMMITTEE'S REVIEW OF ELECTIONS**  
**NOMINATIONS HELD ON FRIDAY, NOVEMBER 7, 2025 VIRTUALLY VIA THE ZOOM**  
**TELECONFERENCING APPLICATION AT 7:00 PM**

**2. TIMELINES AND REQUIREMENTS FOR THE ELECTION NOMINATIONS**

- 2.1 Nominations via the Election Notice opened on Wednesday, October 22<sup>nd</sup>, 2025.
- 2.2 Deadline for submission of duly completed nomination forms was set at **5p.m on Tuesday, November 4<sup>th</sup>, 2025.**
- 2.3 Nominees for the office of Chairman, Vice Chairman and Secretary must have previously served in the Executive Committee for not less than 2 years.
- 2.4 Nominees to attach their Call to Bar Certificate, evidence of payment of 2024 and 2025 BPF and Branch Dues as at when due and SPIDEL's 2025 Dues paid no later than September 30, 2025.
- 2.5 Nominees to also attach their Nominators' Call to Bar Certificates, 2025 BPF and Branch Dues paid as at when due and 2025 SPIDEL Dues paid no later than September 30, 2025.

**4. REVIEW OF NOMINATIONS**

- 4.1 **PAUL BABATUNDE DAUDU SAN:** Duly completed and signed Nomination form with all the required documents were received on November 4<sup>th</sup> at 3:41p.m. However, he had not previously served in the Executive Committee and his first Nominator, Abdullahi Karaye Musa only paid his SPIDEL dues on October 25, 2025.
- 4.2 **JOHN AIKPOKPO-MARTINS:** Duly completed and signed Nomination form with all the required documents were received on November 4<sup>th</sup> at 4:06p.m. He also stated that he had previously served in the Exco as the Chairman from 2023 – 2025.
- 4.3 **DR. UJU ROSELYN CHIEMEKA AGOMOH:** Duly completed and signed Nomination form with NONE of the required documents was received on November 4<sup>th</sup> @ 4:55p.m. However, at 5:22p.m on the same day, the same Nomination form was resent with only her Call to Bar Certificate, proof of SPIDEL dues paid within time, an unidentified proof of BPF payment made on August 25, 2025 and her Nominators complete documents, except the second Nominator, Abdullahi Karaye Musa's SPIDEL dues which was paid on October 25, 2025.
- 4.4 **DR. ANNE URUEGI AGI:** Duly completed and signed Nomination form with all the required documents were received on November 4<sup>th</sup> at 10:54a.m. She also stated that she had previously served in the Exco as a Council Member from 2021 – 2023.
- 4.5 **VINCENT ADEBAYO ADODO:** Duly completed and signed Nomination form with all the required documents were received on November 4<sup>th</sup> at 1:51p.m.
- 4.6 **TOSAN BARBARA ONWUBIKO:** Duly completed and signed Nomination form with all the required documents were received on October 30<sup>th</sup> at 12:56p.m.
- 4.7 **MOJIRAYO OGUNLANA:** Duly completed and signed Nomination form with all the required documents were received on November 4<sup>th</sup> at 4:26p.m. She also stated on her form that she's currently serving as that Publicity Secretary of the Transition Committee.

- 4.8 **MONDAY ADJEH:** Duly completed and signed Nomination form with all the required documents were received on November 4<sup>th</sup> at 3:45p.m.
- 4.7 **PRINCESS FRANCESCA FRANK-CHUKWUANI:** Duly completed and signed Nomination form with all the required documents, excluding her two Nominators' Call to Bar Certificates, were received on November 4<sup>th</sup> at 4:20p.m. She also indicated in her form that she had served previously in the Exco as Secretary from 2021 – 2023 and as Vice Chairman from 2023 – 2025.

## 5. DECISIONS OF THE ELECTORAL SUB-COMMITTEE

- 5.1 After exhaustively deliberating on the nomination forms received from the Nominees, the following were the decisions of the Sub-Committee on each of the nominations:

### G. Chairman:

1. **Paul Babatunde Daudu SAN:** **DISQUALIFIED** on the basis of having not served previously in the Exco in addition to his 2<sup>nd</sup> Nominator's SPIDEL Dues which was paid out of time.
2. **John Aikpokpo-Martins:** **QUALIFIED** on the basis of his previous Council membership which the Sub-Committee took "judicial notice" of, in addition to his truncated Chairmanship position which the Sub-Committee also took judicial notice of as having lasted from 2023 – 2024, when it was terminated by NEC in 2024, as against 2025 which he wrote and which the Sub-Committee believed must have been erroneously stated.
3. **Dr. Uju Roselyn Chiemeka Agomoh:** **DISQUALIFIED** on the basis of not having served previously on the Exco and not providing the required documentary evidence, except for her Call to Bar Certificate, 2025 SPIDEL Dues receipt, a BPF payment receipt with no name dated August 25, 2025 and her Nominators' documents which were all sent out of time and as such discountenanced.

### H. Secretary:

1. **Dr. Anne Uruegi Agi:** **QUALIFIED** on the basis of fulfilling all the requirements.

### I. Assistant Secretary:

2. **Vincent Adebayo Adodo:** **QUALIFIED** on the basis of fulfilling all the requirements.

### J. Treasurer:

2. **Tosan Barbara Onwubiko:** **QUALIFIED** on the basis of fulfilling all the requirements.

**K. Publicity Secretary**

1. **Mojirayo Ogunlana: QUALIFIED** on the basis of fulfilling all the requirements.

**L. Elected Members**

3. **Monday Adjeh: QUALIFIED** on the basis of fulfilling all the requirements.
4. **Princess Franchesca Frank-Chukwuani: QUALIFIED** on the basis of fulfilling all the requirements, excluding the lack of submission of her Nominators' Call to Bar Certificates but which the Sub-Committee decided to waive having taken judicial notice of the fact that the Nominators are legal practitioners.

**6. RECOMMENDATION**

- 6.1 The Sub-Committee recommends that a proper, transparent and rancour free election be conducted, in accordance with its mandate, with every SPIDEL member, who will be present in Uyo on the day of the election, encouraged to vote.
