

RE: THE CONTEMPTOUS SHORTLISTING OF CANDIDATES FOR THE APPOINTMENT OF HIGH COURT JUDGES AND CUSTOMARY COURT OF APPEAL JUDGES OF ABIA STATE BY ABIA STATE JUDICIAL SERVICE COMMISSION (J.S.C) AND YOUR LETTER DATED 12TH MARCH, 2025 WITH REF.JSC/S,83/11/176 ADDRESS TO ALL THE CHAIRMEN, NIGERIA BAR ASSOCIATION DURING THE PENDENCY OF SUIT NO: FHC/UM/CS/82/2024 AT THE FEDERAL HIGH COURT UMUAHIA, IN DISPARAGE TO THE PENDING JUDICIAL PROCESS OF COURT, FLAGRANT DISREGARD OF APPLICATION OF LIS PENDIS, BREACH OF THE RULE OF LAW, WITHOUT DUE PROCESS OF LAW, AND RESORT TO SELF HELP IN THE PROCESS OF APPOINTMENT OF JUSGES OF ABIA STATE DURING PENDENCY OF LITIGATION IN THE COURT OF LAW.

As Solicitors to the 2022 shortlisted candidates for appointment of Judges in Abia State, we write you in respect of the above subject matter as hereunder:

(1) That the fresh shortlisting of candidates for appointment as Judges of Abia State by the Abia State J.S.C and your letter Ref. JSC/S.83/11/176 dated 12th March, 2025 addressed to All Chairmen, Nigerian Bar Association and requesting for their comments during the pendency of Suit NO. FHC/UM/CS/2024 challenging the

validity of the 2024 process of appointment of Judges of Abia State, amounts to **resort** to SELF HELP, Flagrant disregard to the due process of Law, Breach of the Rule of Law, Mockery of the Judicial process and contempt of the Judicial Proceedings of a Court of Law.

- (2) That all the Chairmen, Nigeria Bar Association Branches of Abia State to whom your letter dated 12<sup>th</sup> March 2025 was addressed to, are parties to pending suit NO. FHC/UM/CS/2024, and by the dictates of the Rule of Law and application of the doctrine of Lis Pendis, the parties to the pending suit including the Chairmen are all disallowed by parties to the pending suit including the Chairmen are all disallowed by Law from taking any step or commenting on the propriety or otherwise of the suitability of the shortlisted candidates made during pendency of litigation over the 2024 process of appointment of Judges of Abia State in suit NO:FHC/UM/CS/82/2024 at the Federal High Court Umuahia.
  - (3) That the shortlisting of the candidates named in your aforesaid letter dated 12<sup>th</sup> March, 2025 with Ref. JSC/S.83/11/176 by the Abia State Judicial Service Commission was not only made in a matter Sub-Judice but after the service on you and all the parties to the suit NO:FHC/UM/CS/82/2024 of Pending Motion for Interlocutory Injunction restraining and the Abia State Judicial Service Commission (J.S.C) from continuing or from taking any further steps in the 2024 Appointment of Judges of Abia State during the pendency of the suit.
    - (4) That having regard to the operation of the Rule of Law, it is disrespectful and contemptuous of the Judicial processes of the Court for you to take the law into your hands by resorting to self-help over the subject matter of suit N0:FHC/UM/CS/82/2024 pending at the Federal High Court Umuahia by going ahead to shortlist names of candidates for appointment as Judges shown in your letter dated 12th March, 2025.

(A copy of your letter dated 12<sup>th</sup> March, 2025 with Ref. 3SC/S.83/11/176 is attached herewith as Annexure 1).

(5) That the **doctrine** of **Lis Pendis Negates** and **disallows** any purported validity to the shortlisted list of candidates and any transfer of any rights or interests to the shortlisted candidates in the process of appointment of Judges of Abia State during pendency of litigation challenging the validity of the 2024 process of appointment of Abia State.

- That by the subsisting Policy of the National Judicial Council (N.J.C), the 2024 process of appointment is already put on hold by reason of the pendency of suit NO:FHC/UM/CS/82/2024 in which National Judicial Counsel (N.J.C), is a party thereto, and as such the purported names of the shortlisted candidates made pende-lite cannot be countenanced during the litigation and even after the litigation.
- That the above legal positions which lend credence to the aforesaid (7) National Judicial Council (N.J.C) policy and yield to the invalidity of the shortlisted candidates and any comments on their suitability made during pending litigation are well spelt out in the decisions of the appellate Court and Apex Court respectively in the cases of;

ii. INEC .V. Youth Party (2023) 7 NWLR (PT. 1833) 249 at 260-263.

THEREFORE, TAKE NOTICE that we shall not hesitate to commence committal proceedings for contempt of Court against all the members of the Abia State Judicial Service Commission and/or any of the parties to pending suit NO: FHC/UM/CS/82/2024 for the above complained contemptuous acts and/or any further contemptuous steps taken over the subject matter of 2024 process of appointment of Judges of Abia State while Sub-Judice and Lis-Pendis.
