
### RESPONSE OF THE NBA IKORODU BRANCH TO THE PUBLICATION BY THE NBA-HRI MONITORING COMMITTEE "PUTTING THE RECORD STRAIGHT"

The attention of the Nigerian Bar Association, Ikorodu Branch has been drawn to the publication credited to the NBA Human Rights Monitoring Committee dated 29th December 2025, titled "NBA Ikorodu Branch Complaint: NBA – HRI Monitoring Team Putting the Record Straight." The Branch does not wish to dwell endlessly on this issue; however, the publication in question contains false and misleading assertions which, in the interest of accuracy, institutional integrity and fairness to our members and volunteers, necessitate this response to put the record straight.

First, it is important to state that the concern raised by the Ikorodu Branch was never about "winning" or losing any competition. The issue raised, clearly and consistently was the gross misrepresentation of the Branch's documented human rights activities as being only six (6) within the stated period, a conclusion that is demonstrably incorrect and hence, demoralizing to the collective efforts of members who volunteered time, resources and professional expertise in service to humanity.

Unfortunately, rather than address this core issue with facts and evidence, the Committee's response resorts to sweeping allegations, inaccurate characterizations of our submissions and an abdication of responsibility for what is plainly a deficient evaluation process.

The initial conditions issued to Branches did not restrict qualifying activities solely to court decongestion, charge numbers, or inmate releases. On the contrary, they expressly recognized other human rights interventions, including seminars, sensitization and enlightenment programmes, advocacy initiatives, prison and police station visits and community outreaches. These categories were fully reflected in the Branch's submission and further evidenced in a brochure with clearly labeled pictorial headings, strictly as corroborative material. Any attempt, after the fact, to narrow the criteria exclusively to court

processes or charge numbers amounts to a post hoc reinterpretation unsupported by the text of the notice earlier issued to Branches.

The NBA Ikorodu Branch submitted through the vice Chairman, three (3) distinct documents of pro bono and human rights activities within the stated period, including a comprehensive Human Rights Compendium, accompanied by a pictorial annexure provided strictly as supporting evidence and CTC of Court judgment.

The submission referenced in the NBA HRI response comprised:

- A compendium of monthly written reports of activities, clearly categorised headings, stated dates in some instances and summaries in other instances, venues or judicial divisions, whichever is applicable
- Picture evidence provided both in the compendium and brochure as corroboration, not as a substitute for facts.

At no time did the Branch request that pictures be assessed independently of the accompanying documentation. To suggest otherwise is either a grave misunderstanding or a misrepresentation.

On the claim of absence of charge numbers, suit numbers, and / or parties, this allegation does not withstand even cursory scrutiny. Dates, locations, courts, judicial divisions, charge numbers, and parties were clearly stated throughout the Compendium. A simple audit reveals not less than thirty-four (34) distinct charge numbers and/or parties, across multiple courts and with dates, which is still in excess of the figures attributed to the Branch by the Committee even if groupings were by dates.

It is therefore surprising that the Committee, while asserting non-compliance appears unable to identify particulars that are plainly set out in the Ikorodu Branch submissions.



The Committee's silence on the non - court based human rights activities contained in the Compendium, activities with clear locations and dates necessarily raises the question whether those interventions were discounted, notwithstanding their express recognition under the applicable earlier published criteria. Human rights work, by its nature, is not limited to concluded litigation alone. To retroactively impose a narrow, litigation only metric betrays a poor appreciation of the justice chain and undermines the very essence of human rights advocacy which the Committee itself purports to promote.

Several of the Branch's activities including sensitization programmes, police station interventions, mediation efforts, domestic violence interventions and community based pro bono engagements are not activities that necessarily culminate in concluded judgments and cannot be evidenced in strict verifiable forms other than pictorial evidence and facts. I believe the institute reserved a right to call for further evidence where in doubt or where clarification is needed. Where litigation related interventions occurred, the Branch supplied details consistent with the nature and stage of such matters, also noting that the certified true copy obtained was submitted while others cannot be processed within the deadline.

Sufficient facts were documented across numerous non-litigation activities; even a brief review made several instances apparent, without the need to survey the entire document. Some highlights are noted below:

### **POLICE AND OTHER LAW ENFORCEMENT COMMITTEE (POLICE DUTY SOLICITORS SCHEME)**

Descriptions of the nature of matters attended to were stated and the location of Complainants' identified and stated the actions taken, without revealing the complainants identity. For the records, this is one of the weekly legal aid sessions of the Branch, reported for a month. A similar report was made for the following dates 14th, 21st and 21st of August, 2025, and the 9th, 16th, 18th and 26th of October on Pages 43 & 53 of the same compendium.

Reports were also made for the D.V Committee on Page 39

Dates: 1st, 8th, 15th and 22nd of July, 2025  
Venue: Cloakroom, High Court Ikorodu  
Activities: Committee sitting to resolve issues bothering on domestic violence, custody, access and child welfare disputes

Similar sittings was noted on the 7th, 14th, 21st and 25th of October, 2025; identifying the actions taken, legal advice, undertakings and referrals where applicable to Court for unresolved issues. Matters were noted to be referred from several units but somehow, despite the facts presented in the compendium, the committee finds the claims to be a mirage, lacking sufficient proof. All these records remain documented and verifiable in our registers and more. Documents I cannot as a responsible Branch Executive publish for data protection reasons.

Even assuming, without conceding, that details of non-litigation Human Rights activities were not provided and the parameters were based on litigation activities alone, the Committee still could not reasonably have arrived at the figure published. The documents submitted clearly show numerous court related matters, identified by suit numbers, courts, parties and dates, also specifying the counsel(s) appearing. If the "Brochure only" was relied upon, how exactly did the committee arrive at its outcome? Please guide me.

I wish to state that verification is the core duty of the Committee and this responsibility cannot be discharged perfunctorily, nor should it be reduced to a mere show of recording assignments for reporting sake. If the exercise is worth undertaking at all, it must be done diligently and responsibly, otherwise, it ought not to be undertaken.

The publication provides no scoring breakdown, no referenced omissions, no analysis nor explanation of how the figure of six (6) activities was reached. In the absence of transparency, the assertion remains unproven and indefensible. Yes, there were general reports and summaries of activities in some cases but what happened to the specifics? Did the numerous specifics also not meet the criteria?

For the avoidance of doubt, this response is not an attack on the Committee, nor is it an attempt to discredit other Branches. It is a principled objection to the careless misrepresentation of documented efforts and the public diminution of the work of volunteers who have consistently served our communities under the banner of the NBA Ikorodu Branch. The enduring efforts of successive Branch leaders and Committees heads to champion human rights and social responsibility, a tradition firmly embedded in the Branch's institutional history will neither be rewritten nor diminished by any external influence.

We therefore place it firmly on record that:

- The Branch carried out far more than six (6) human rights related activities within the stated period
- The Committee's publication is factually inaccurate, misleading and reflective of a deficient review process

Again, the issue raised by the Branch concerns accuracy, fairness and institutional responsibility, not competition outcomes. It is about correcting a public misrepresentation that reduces extensive, documented human rights service to an inaccurate figure. Such a portrayal is not only demoralizing but also undermines the collective efforts of volunteers and members who committed time, resources and professional expertise in service to humanity.

The NBA Ikorodu Branch remains committed to human rights advocacy, justice reform and service to humanity, regardless of mischaracterizations of its efforts. We have never been defined by awards nor recognitions.
