I wish to state categorically that I did not at any time give consent expressly or impliedly to the said individual to use my stamp and seal or to act on my behalf in any professional capacity. The acts complained of amount to serious criminal offences including but not limited to **Impersonation, Forgery, Obtaining by False Pretence and Personation** which are contrary to the

In view of the foregoing, I respectfully request the Nigerian Police Force Bauchi State Command to:

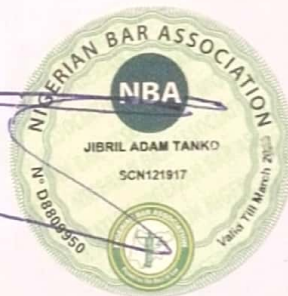
1. Conduct a thorough investigation into this matter.
