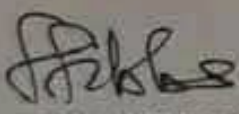
ORDER FOR INTERIM INJUNCTION

- 1 That an Interim Injunction is hereby made restraining the 32nd Defendant i.e. The Hon. - 2 That leave is also granted to the Claimant /Applicant to serve this interim order, the Originating processes and all other subsequent processes in this suit meant for the 1st - 31st Defendants, to wit: by pasting the said processes at the gate of the Rivers State House of Assembly Quarters, Opposite former NDDC Headquarters, Aba Road, Port Harcourt, Rivers State and to serve same for the 32nd Defendant through any staff of the Rivers State Judiciary at the Chief Judge's Chambers, High Court
