The letter which should be written in the Applicant's Letter Headed Papers (with telephone numbers(WhatsApp), email addresses), should be signed personally by him/her (Not by a proxy or agent) and must contain:-

- (a) His/Her full names as enrolled in the Supreme Court Rolls, and the current names if different from the ones in the SC Rolls,
- (b) Supreme Court Enrollment Number,
- (c) Year of Call to the Bar
- (c) Branch Name
- (d) Confirmation or otherwise of NEC membership and/or Branch Executive and/or Section and/or Forum as prescribed by the NBA Constitution,
- (e) Confirmation of payments of practicing fees and Branch dues as and when due as prescribed

3. The letter which must be accompanied with clear, clean, legible, current and valid photo ID of the Applicant (ECOWAS/NIGERIAN Passport data page or NIN Slip/Card, or Voters Card(PVC) or Driver's License) and the other supporting documents should be addressed to:


