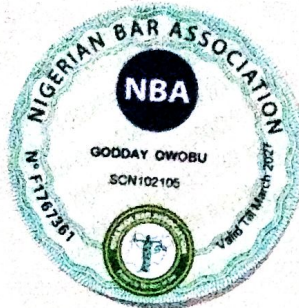

DEMAND FOR THE IMMEDIATE REMOVAL OF UNQUALIFIED/INELIGIBLE MEMBERS FROM THE LIST OF ELIGIBLE VOTERS IN THE FORTHCOMING ELECTION.

Mr Chairman, I must start by commending your Committee for the good work you are doing. The task that has been assigned to you is one that is very complex and sensitive, as such, it is my belief that it must not be left to you alone.

After carefully studying the Interim List of Eligible Voters of NBA Gwagwalada Branch Election 2026 published by your Committee Secretary in the early hours of today 24th May, 2026, I wish to bring to your attention a number of names that should not be on the said list as they have not fulfilled the requirements of the law particularly section 15 subsection 1 of the NBA Uniform Bye – Laws for Branches 2025.

By the Certified True Copy of the attendance register of the branch from May, 2025 to April, 2026, the following members are ineligible to vote in the forthcoming election:

1. **Akinrinlola Akinjide Dada** who was listed as number 60, only attended **September and October, 2025, January and May, 2026 meetings**. He is **not eligible** as he has just **4 meetings**.
2. **Sulayman Morenikeji Sulayman** who was listed as number 171, only attended **October and November 2025, January and February, 2026 meetings**. He is **not eligible** as he has just **4 meetings**.

3. **Suleiman Solihu Daddy** who was listed as number 120 paid his **2025 Bar Practicing Fee and Branch Dues out of time**, as such he is **not eligible**.
4. **Adeniran Gbenga Dada** who was listed as number 210 only attended **February, March, April and May, 2026 meetings**. He is **not eligible** as he has just **4 meetings**.
5. **Asiawu Belgore** who was listed as number 214, only attended **September, October and November 2025 meetings**. She is **not eligible** as she has just **3 meetings**.
6. **Ibilola Rihanat Adebanjo** who was listed as number 184, only attended **January, February and March, 2026 meetings**. She is **not eligible** as she has just **3 meetings**.
7. **Roseline Michael** who was listed as number 206, only attended **January, February and March, 2026 meetings**. She is **not eligible** as she has just **3 meetings**.
8. **Clementina Chika Okeke, Phd.** who was listed as number 158, only attended **February, 2026 meeting**. She is **not eligible** as she has just **1 meeting**.
9. **Fagbohunlu Victoria** who was listed as number 209, only attended **October and November 2025, January and February, 2026 meetings**. She is **not eligible** as she has just **4 meetings**.
10. **Ehihiator Vivian Chinyere** who was listed as number 205, **did not attend any meeting** between May, 2025 and April, 2026. As such, she is **not eligible**.
11. **Temitope Jane Leko** who was listed as number 132, only attended **February, 2026 meeting**. She is **not eligible** by this record as she has just **1 meeting**.

In the light of the above, I hereby demand the immediate removal of the above listed names from the list of eligible voters in the forthcoming election.
